All installations shall be in conformance with the Plumbing Code. **No work shall be concealed until it has been inspected.** When ready for an inspection call **248-348-5830 by 3:30 P.M. the day before.** **YOU MUST HAVE THE PERMIT NUMBER AND ADDRESS AVAILABLE WHEN SETTING UP THE INSPECTION.**

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested / conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit; or if the authorized work is suspended; or for a period of six months after the time of commencing the work; or date of last inspection.
