9. Board Communication & Reports:

- **A.** Robert R. Nix, II reported that he met with other Western Wayne members and legislatures in Lansing to discuss common statewide issues including protection for adjacent communities with regards to Solid Waste. WTUA, which is comprised of Northville Township, Plymouth Township and Canton Township, met to discuss pulling out of the Wayne County sewage and moving to the Ypsilanti facility; they also spoke about the possibility of creating a water authority to get a wholesale rate, which could potentially reduce the cost increase to residents.

- **C.** Marjorie Banner reported that the Historic District Commission had a special meeting with the people who bought the old Ford Village building to see what the plans for the structure were; at this early stage the HDC likes what the new owners are doing. The Thayer's school house will be shingled this summer, as the funds have been raised for this next step. The clothing drive was a very successful for both Civic concern and for Vista Maria; a special thank you to Trustee Shadko for his help with this event. Finally, Thayer's Corner had a terrific work day on April 29th; thank you to everyone who came to help.
- **D.** Richard Allen reported that the Planning Commission met to review a single item for Five Mile & Beck Road. They approved the single family home portion of the project; the townhomes were deferred for further architectural study. Finally, there will be a road closure entering the park from Five Mile Road for about a five week period this summer; they are trying to complete this between soccer seasons.

- **E.** Symantha Heath reported that the ZBA did not meet this month. She also reported that the Communication Committee has received great feedback regarding the new Township app; she thanked Director Nicoloff for all the hard work during this process.
- **F.** Mindy Herrmann reported that Seniors met with the new Senior Director, Pam Cameron; transportation and events are up for Seniors and Senior-fest is coming up on June 7th. Parks and Rec met, with two new members, to discuss the Fish Hatchery Park project and funds.
- **G.** Fred Shadko reported that 675 residents have already downloaded the app at the one month anniversary, with the Communication Committees goal being 1,000 downloads the first year. On Saturday the high school is hosting Armed Forces Day and the Rouge Rescue will be going on. The Saturday of Memorial Weekend, Thayer's Cemetery Association will be doing a tribute to the Veterans with help from the Friends of the HDC. Finally, the School Improvement Commission is continuing to evaluate current school conditions while they debate about a millage request this November.
- **H.** Chip Snider reported that the attributes of this team have helped to put Northville Township far beyond our competitors.
